- 4. Refer Ministry of Finance, Department of Expenditure (Public procurement Division) notification dated 23 July 2020 regarding restrictions under Rule 144 (xi) of the General Financial Rules (GFRs), 2017, Bidders not found eligible will not be considered. Self certification regarding compliance is required on the letter head of the bidder.
- 5. Tenders received after the expiry of the time & date notified for receiving tenders, will not be considered under any circumstances whatsoever. - 15. The Successful bidder will complete the entire work within 7 days from date of issue of work order.
- 16.MINIMUM MAINTENANCE STANDARD REQUIRED DURING WARRANTY PERIOD: The selected bidder should ensure that the equipment reported faulty on any working day is set right within 72 hours of reporting the complaint and in no case, later than three working days of the Corporation. In case, the hardware cannot be repaired within the stipulated period, the vendor should provide replacement of the same till the hardware is returned duly repaired without any additional charges during guarantee /warranty period.
